Treasurer Woltjen provided the commission with the financial report.

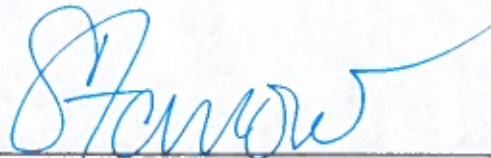
