In order to receive your Commission Certificate as required by state law, you must file a copy of your Oath of Office to the office of the Secretary of State. The Probate Judge of your county must certify to the Secretary of State's office that you were duly elected/reelected to a four/six year term, and that you have filed your oath and bond as required by state law. There is a five dollar (\$5.00) commission fee required.

Requirements for Commission Certificate:

- 1. Copy of the Oath of Office
- 2. Original SOS-C-Form-1 (verification of election, bond, and oath, which should be signed by the Probate Judge and his/her signature notarized)
- 3. <u>\$5.00 Commission Fee</u> (Please make checks or money orders payable to Secretary of State).
